**Important Instructions about Freeze and Float Option for Higher Education Course to the Heads of the Colleges/Institutes and Candidates.**

- 1) There is no provision of Facilitation Centre (FC) and Admission Reporting Centre (ARC) for Higher Education Professional Courses.
- 2) The Admissions will be finalized at the level of Admitting College.
- 3) For “Freeze” and “Float” option the following Logic will be applied:--
- 4) The Candidates who have been allotted the College of their First Choice/Preference in the First/Second Round of Allotment and if they do not seek admission by paying stipulated fee applicable in the college of their First choice/Preference in the First/Second round, they will be out of the Admission Process till Third round. Their candidature will be considered only in the Third Round.
- 5) The Candidates who is allotted college of second or subsequent preference in First, Round of Admission and seek admission in the Allotted College by paying stipulated Full fee of the College/Institute or Seat Acceptance Fee of Rs. 3,000/- or 1,000/- as applicable as per the category of the Candidate will be considered to have exercised a “Float Option” and will be considered for betterment in the Second Round.
- 6) The candidate who has been allotted college of his second or subsequent preference in First Round of Admission and does not seek admission by paying stipulated Full fee of the College/Institute or Seat Acceptance Fee of Rs. 3,000/- or 1,000/-, he will not be considered for the Second Round. The Candidate who desires to reject the seat allocated to him in the First Round and does not pay the seat acceptance fee can do so. But these candidates will not be considered for allocation in the CAP Round II.
- 7) The students, who do not seek admission in the First and Second rounds, will be considered to have exercised Float Option and they will be considered for allotment in the Third Round as per their options as per provision detailed in (3) Conduct of CAP Round III.
- 8) Before the start of Third Round, all the candidates who have not sought admission in the earlier rounds, will be able to edit/update their College Options as per the Time Table available on the web site.
- 9) All Colleges/Institutes/candidates participating in CAP will follow these instructions.
