- c) Examination forms will not be accepted unless all the College and Hostel dues are paid.
- d) Examination forms of Regular Students will be accepted subject to completion of Tutorials. In case of nonsubmission of the tutorials, the examination forms are liable to be called back from the University.

Submission of Examination Forms:

- a) Application forms of students (1) who fail to keep minimum required attendance; (2) whose Transference / Eligibility Certificates are not received WILL BE REJECTED.
- b) All the Govt. Concession cases (EBC, FF, PTC, STC, BC, etc.) whose applications for studentships will be rejected by the Government shall have to pay all the College fees.
