- F. Footnotes- Font Style- Times New Roman, Size-10, Line Spacing- 1, Alignment- Justified.
- G. Page Margin- 2.54 cm on all sides.
- H. Essay must be submitted only in a Word Doc. (doc./docx.) format.
- I. For maintaining anonymity, the name of the author/institution should not be mentioned anywhere in the essay.
- J. All essays must be the original work of the authors. Any kind of plagiarism will lead to outright disqualification.
- K. Essays published elsewhere or selected/submitted for publication elsewhere shall be disqualified.
