They have applied for the registration of their trade mark WEASLEY'S WIZARD WHEEZES in respect of toys and edibles in India, where they plan to open an outlet. They already have a substantial client base through their owl order business. Dolores Umbridge, the proprietor of WIZARD KAT WHEEZES, a cat shop which sells cat toys and cat food, has filed a pre grant opposition against the registration. You are the lawyer representing Fred and George Weasley. Prepare a counter statement justifying the registration of your client's mark on the basis of relevant sections and case laws.

Tony Stark was abducted by terrorists in Afghanistan, and built a suit of armor powered by super batteries to escape. Upon rescuing and reaching U.S., he improved the suit of armor and made a miniature arc reactor to power the suit. The miniature arc reactor is an exact replica of a 200 ton 40 sq km sized arc reactor (nuclear fueled) that powered the Stark Industries Complex. Before Tony Stark's breakthrough, no scientist/engineer had been able to determine a method to reduce the scale of the arc reactor while ensuring the safety of the nuclear reaction at the core at the same time. Stark Industries filed for a patent over the suit of armour as well as the minimized. rc reactor. Six months after the application was filed in the U.S. a patent application was filed in India as well. You are the Controller of Patents.
