### **Detailed steps:**

#### **1. Registration for the Competition.**

Details of Registration

- Registration Fee INR is 150/- including GST (For Non ILS Students)
- Registration fees is not refundable.
- Details for registration must include the Name of the participant, Name of the College, Year/Class in which studying & Email address and a scanned copy of the College ID card must be uploaded.
- The Competition is open for Students of **4<sup>th</sup> & 5<sup>th</sup> Year of the Five Year Law Course and 2<sup>nd</sup> & 3<sup>rd</sup> year of the Three Year Law Course and Post Graduate Students (LL.M)** .
- **Last Date for Registration for the competition is 16<sup>th</sup> December 2021**

#### **2. Book Chapter Alternative Choice:**

- a. The scanned copy of the chapter from books selected by the college shall be disclosed **only to the registered participants** via email **on 17<sup>th</sup> December 2021**.
- b. The chapters are primarily based on the theme of family law , personal law and gender.

#### **3. Submission:**

- a. The Book Chapter chosen for analysis has to be submitted by **28<sup>th</sup> December 2021** 23:59 hrs on the following Email [llmdepartment@ilslaw.in](mailto:llmdepartment@ilslaw.in)
- b. Submission received after 22<sup>nd</sup> December 2021 will be disqualified.
- c. The Submission must include the Title of the Chapter, Name of the Participant, Name of the College.
- d. Font: Times New Roman, Size: 12 pt. & Line Space: 1.5
- e. Word Limit for the Submission is 700-800 words.
- f. The submission file must be scanned PDF and sent as an attachment.

2. Research undertaken (in terms of the how the literature in that specific subject has evolved, prevailing theories, divergence of opinion found and cited in the write-up.	30
