

Post Graduate Diploma in Alternative Dispute Resolution Methods (ADRM) (Through Distance Learning)

FREQUENTLY ASKED QUESTIONS

1. Is Post Graduate Diploma in Alternative Dispute Resolution Methods conducted by the Indian Law Society for Arbitration and Mediation (ILSCA) recognised by any University?

- No. This course is an autonomous course conducted by the Indian Law Society, Pune.
- Indian Law Society is an independent body, is a public charitable trust, registered under the Society's registration Act and has no affiliation with the UGC nor with the University of Pune nor is a deemed University.
- Thus, Indian Law society is free to design its courses – as regards, the design, its curriculum and its duration and its methods of assessment.
- Various Diploma/certificate courses including the PG Diploma in ADR Methods are run by the Indian Law Society with due approval of the Governing Council of the Indian Law Society.
- We call the course PG Diploma because we only admit students who are graduates in any faculty – law science or arts.

2. When do applications open and what is the deadline for applying?

- Applications for the Diploma course for the year 2021-22, will be invited on **12th July 2022**.
- The admission notice will be released on **4th July 2022 on the ILS website - ilslaw.edu**
- The last date for registration for the Diploma course is **6th August 2022**.

3. Whether course is correspondence course or classroom mode?

- PG Diploma in ADRM, conducted by ILSCA is conducted in hybrid mode – The larger part of the programme consists of self-study where the study material is sent to the student and the student must study and learn on their own. In addition, there will be online classes conducted on the various topics of the course at intervals by experts on topics which are part of the programme.

4. What is the duration of the Course?

- The duration of the course is three months.

5. Fees for the course – inclusive of Reading Material

- **Rs. 42,373/- + Rs. 7,627 (18 % GST) = Rs.50,000/-**

7. Whether Reading material will be provided?

- **Reading material will be provided offline (Hard Copies) and online from time to time**

8. Where will be the assessment pattern?

- At the end of the course the final assessment of the student is done which is based on
 - Project Submission (participants can choose any topic from list provided to them)
 - Attendance for the contact classes
 - final examination (Online)

9. Are recent graduates eligible to apply for the course?

- Yes, recent graduates are eligible to apply for the course.

10. What documents are to be submitted at the time of Admission?

- Candidates selected for admission are required to produce the following documents: (scan copies and submit online)
 1. Passing Certificate of the qualifying Examination
 2. Statement of marks of the qualifying Examination

3. One passport size photograph

11. What is the procedure for cancellation of admissions and refund if any?

- Candidate who intends to withdraw their admission must apply expressing his/her inability to continue with the course with valid reasons. The chart for refunding of the fees on withdrawal of admission is as under:

On Cancellation of Admission	Fees to be refunded
1. Within 8 days of admission	80 % of total Fees
2. 9 to 15 days of admission	50 % of total Fees
3. After 15 days of admission	No refund

P.S. - Fees once paid will not be adjusted to the subsequent course, under any circumstances, after the commencement of the course for which the fees are paid.
