## About Us

The ILSCA was established on 3<sup>rd</sup> December 2016 by the Governing Council of the Indian Law Society (ILS). ILSCA is established with various objectives in mind.

One of the main purposes of establishing this Centre is to provide training to students of law, legal professionals and others who are interested in learning the process of Arbitration and Mediation through training programmes. The Centre also has state-of-art infrastructure and facilities for holding ad-hoc Arbitration and Mediation and Institutional Arbitrations and Institutional Mediations, both in domestic as well as International commercial situations.

Participants who successfully complete their mediation training with the ILSCA will be eligible to become IMI Qualified Mediators **should they choose to apply for such recognition** with IMI, upon payment of a nominal requisite fee (EUR 50) to be paid through ILSCA to IMI.

Accreditation by the IMI will help participants to get worldwide global recognition and get exposure in the field of mediation, globally. IMI-certified mediators benefit from IMI's global brand, gain credibility in practice, qualify for other opportunities globally and become recognised as distinguished mediators- like the IMI certified Mediators become automatically eligible for certification by the Singapore International Mediation Institute.
